Present: Councillors Jones (Deputy Town Mayor); Bromilow; Gardner; Hanna; Laurence; Parker; Richmond and Smith.

In attendance: Derek Whiteway (Acting Clerk) and Mel Guilding, Town Crier

24017 Apologies: Apologies were received from Councillors Grisenthwaite; Roe and Turner and accepted. Apologies also received from Ward Councillor Louise Belcher; County Councillor Phillippa Williamson and Town Clerk, Bob Bailey

24018 Declaration of interests and dispensations: Declarations of interest relating to connections with local organisations were made and accepted. Requests for dispensations relating to 1 & 2 Station Buildings and Planning Application 21/00899/HYB were granted.

24019 Urgent Business: The Deputy Town Mayor reported that following the statutory notice for a vacancy on the Town Council the position can now be filled by co-option. This has been published with a deadline for expressions of interest by 29th February 2023.

Councillors were reminded to submit their profiles for the new Council website to the Town Clerk as soon as practicable. Councillors were also reminded that they are invited to the 'Welcome' event for the Carnforth Community Food Club on 23rd February 2024 at 2pm at the Carnforth Hub, Kellet Road.

Councillor Smith informed Councillors of the date for training on the Community Emergency Plan on 17th March 2024 (NOTE: This date has since been changed)

24020 Minutes: Subject to a minor amendment, it was **RESOLVED that the Minutes of the meeting of Carnforth Town Council held on 17th January 2024 be approved.**

24021 Adjournment for public discussion and information only updates:

1) **Public Discussion:** The Town Crier advised that Commonwealth Day is Monday, 11th March, the theme for which is "One Resilient Common Future".

ACTION: Commonwealth Affirmation to be read at the War Memorials Garden at 11.00am. Councillors were also advised that the 75th Anniversary of the Commonwealth is on Friday, 26th April – further details to follow.

2) **Councillor & Clerk updates / matters:** Councillors reported on a range of matters and actions including:

- a) Thanks from the local Ramblers Association following work recently carried out public rights of way;
 - b) Reference was made to the large overhanging trees on Russell Road being on private property. **ACTION: Councillor Hanna to enquire with Lancaster City Council on any powers to enforce the cutting back of these tree**
 - c) Mental Health Wellbeing Conference (organised via Rotary) to be held on Friday, 19th April 2024, from 10.00am to 12.30pm, including refreshments;
 - d) Reference to growing concerns over the condition and appearance of Carnforth Railway Station;
- 3) **Reports of County & Ward Councillors:** There was no reports to consider. Councillor Hanna would report on relevant matters on the Agenda.
- 4) **Reports from outside bodies:** Councillor Parker reported on a recent meeting of the Carnforth & District Twinning Association. The Saily-sur-la-Lys association has more than double the number of members compared to Carnforth and efforts continue to increase the latter's membership. The visit to Carnforth is planned for 21st - 25th August. The Carnforth & District Twinning Association Annual General Meeting is scheduled for Monday, 4th March.
- Councillor Parker also reported on Carnforth Chamber of Trade meeting and liaison with Lancaster Chamber of Commerce. Forthcoming Expo to be held at the Royal Station Hotel. AGM scheduled for 11th March.
- 5) **Report of the Town Clerk:** Councillors considered the written report including the ongoing issues with the heating system at Crag Bank Village Hall and request for a letter of authorisation to be sent to Electricity North West for an enhancement to the mains electricity supply.
- Councillors noted the work done to develop a new website and it was requested that, following the cancellation of the meeting of the Finance & Governance Committee, they be given a further opportunity to consider the website before it is formally launched.
- It was then **RESOLVED that reports of Town Councillors, the Town Clerk & Outside Bodies be noted and that the Town Clerk provides a letter of authorisation for the installation of a three phase electricity supply at Crag Bank Village Hall.**

24023 **No. 1 & 2 Station Buildings:** The Town Clerk had circulated a recent report from the Building Control Officer dealing with the most recent issues relating to 1 Station Buildings.

Lancaster City Council are familiar with both properties and been dealing with dangerous issues associated with them since 2019.

It was noted that not all Councillors had had an opportunity to consider the written report, but the action being taken by Lancaster City Council as set out in the report were generally well received. Councillor Smith again commented on the impact that Heavy Goods Vehicles along Warton Road may be having on properties. After some discussion it was **RESOLVED that representatives from Lancaster City Council and County Highways be invited to a meeting of the Town Development & Planning Committee to discuss the issues further.**

It was then **RESOLVED that the update on the planning authority's decisions be noted and that the Town Clerk submits a request for a Carnforth Town Council representative to speak at the Planning Committee considering Planning Application 19/00541/OUT .**

24025 Town Development & Planning Committee: Councillor Parker reported on the recommendations, updates and actions arising from the meeting of the Town Development & Planning Committee held on 5th February 2024, including:

- 1) Project Swift:** Councillor Bromilow referred to a swift and bat box project in Over Kellet Parish Council using Biodiversity Grant funding available from Lancashire County Council. The Acting Clerk was able to provide further details and offered to provide contact details of the Over Kellet Parish Councillor leading on the project. **Action: The Town Clerk to report on whether Carnforth Town Council's receives biodiversity funding and, if so, what this is used for;**
- 2) Planned events 2024:** Updates on events planned in 2024 including Carnforth Fringe; D-Day 80 commemorations and War Memorial Centenary;

After some comments, it was **RESOLVED that the report, actions and recommendations of the Town Development & Planning Committee be noted and approved.**

24026 Property & Environment Committee: Councillor Richmond reported on the recommendations, updates and actions arising from the meeting of the Property & Environment Committee held on 6th February 2024, including:

- 1) Allotments:** Update on the ongoing review of the districts allotments by LESS and 'community conversations' being held throughout February;
- 2) Environmental & Public Realm:** Environmental matters and actions in the last month;
- 3) Carnforth Civic Hall:** The Facilities Manager had reported that on servicing of the boiler over the summer.

The number of fire extinguishers in the building which are in excess of that required under current regulations. The Town Clerk advised that a revised service level agreement is now in place with the fire alarm and maintenance providers.

- 4) **Crag Bank Village Hall:** The Town Clerk had provided a further update on the ongoing problems relating to the heating system and actions taken. Councillors had visited the building raising matters relating to hire fees, storage and fire risk arrangements. The Town Clerk had responded to each of these at the Property & Environmental Committee meeting.

Councillors supported the actions taken to date and it was acknowledged that there was a need for confidentiality whilst complaints and allegations made by users of the hall are being investigated and actions taken to address the issues raised.

Draft Minutes of the meeting held on Monday 4th March 2024

Present: Councillors Parker (Chair), Grisenthwaite (Town Mayor); Hanna; Laurence. One member of the Carnforth Chamber of Trade

In attendance: Bob Bailey, Town Clerk & Responsible Finance Officer

24023 **Apologies:** Apologies were received from Councillors Turner and Smith

24024 **Declaration on interests and dispensations:** There were no declarations of interest or requests for dispensations directly relating to matters on the agenda.

24025 **Urgent Business:** The Town Clerk advised Councillors on two matters raised at the last meeting of Carnforth Town Council that are relevant to this committee. The letter received from Lancaster City Council's Building Control Officer represents a comprehensive report on the latest position regarding 1 and 2 Station Buildings, Warton Road, Carnforth. The officer does not work locally and will not be in a position to attend Carnforth Town Council meetings but has committed to providing updates on actions going forward. Both buildings are now considered to be safe.

The Town Clerk, reminded Councillors that Carnforth Town Council had opted in to the Biodiversity funding available from Lancashire County Council and advised that in 2023/2024 the grant had been earmarked for community plots at Highfield Allotments.

Councillors had been made aware that Lancaster City Council are in the early stages of the Lancaster District Local Plan Review. Councillor Hanna is attending a Neighbourhood Plan Forum on Tuesday 5th March 2024 to consider the review and what impact this may have on the Carnforth Neighborhood Plan. **ACTION: Councillor Hanna to feedback on the main matters and outcomes from the Forum.**

24026 **Minutes:** It was **RESOLVED that the Minutes of the meeting held on Monday 5th February 2024 be accepted.**

24027 **Public participation and information only updates:** The Chamber of Trade representative requested that Carnforth Town Council considers working alongside the Chamber of Trade on the Carnforth Christmas lights switch on from 2024 onwards. There followed a discussion on how this would work in practice, including establishing a Christmas Lights Working Group/Committee. It was then **RESOLVED that it be recommended that, in principle, Carnforth Town Council agreed to work in collaboration with the Carnforth Chamber of Trade on the Christmas Light Switch on from December 2024.**

Councillors were informed that the first Carnforth Business Expo would be held on Saturday 23rd March 11am – 3pm at the Royal Station Hotel, Carnforth.

After some discussion, it was **RESOLVED that Carnforth Town Council be represented at the event.**

There followed a brief discussion around previous, unsuccessful, attempts at establishing a Carnforth Business Improvement District (BID). **ACTION: Councillor Hanna to speak to the Directorate of Economic Growth and Regeneration at Lancaster City Council on the key matters needed to successfully establish a Business Improvement District.**

Actions & Updates: There were no updates in addition to matters included within the Committee agenda .


24030 Town Development: The committee considered the following events, updates and opportunities:

- 1) **Carnforth Fringe:** In Councillor Smith's absence, the Town Clerk provided an update on the progressing plans for the Carnforth Fringe over the period 13th – 20th July. In the coming weeks as plans are firmed up the Carnforth Fringe will be promoted in a variety of ways. Councillor Smith continues to seek funding from local outlets and organisations to support the event.
- 2) **D-Day 80:** Plans will be developed in the coming weeks, including encouraging local schools and organisations to get involved in the commemorations.
- 3) **War Memorial Gardens – Centenary 2024:** Councillors Laurence provided an update on progress relating to events over the weekend of 9th and 10th November 2024. Carnforth Chamber of Trade will support this event. The Town Clerk reported that the company he had contacted had visited the War Memorial and, subsequently, declined to undertake the refurbishment works due to other commitments. Another contact has been suggested. **ACTION: Town Clerk to make further enquiries regarding the refurbishment of the War Memorial.**

24022 Apologies: Apologies were received from Councillors Grisenthwaite and Turner

24023 Declaration on interests and dispensations: There were no declarations of interest directly relating to items on the agenda

24024 Urgent Business: The Town Clerk advised that the report received from Lancaster City Council's Building Control Officer regarding 1 and 2 Station Buildings, Warton Road, Carnforth was a comprehensive update of the latest position and that a commitment had been given that Carnforth Town Council will be kept informed as the matter progresses. Both buildings are now considered safe.

24025 Minutes: It was **RESOLVED that Minutes of meeting held on Tuesday 6th February 2024 be approved.**

24026 Public participation and information only updates: There were no members of the public present.

Actions & Updates: There were no actions and updates in addition to items on the meeting agenda.

24027 Carnforth (Highfield) Allotments: The Town Clerk reported on the district wide 'community conversation' on allotments that was held at Carnforth Civic Hall on February 16th February. The meeting was poorly attended but was a very useful insight into the way that allotments across the district are managed and are developing. The review carried out by LESS and commissioned by Lancaster City Council had identified a wide variety of governance arrangements, good practice and lessons to be shared and learned.

The transition from the Highfield Allotments Committee to Carnforth Town Council last year was praised as was the fact that the Highfield Allotments now boasts two 'community plots'. The Council's decision to charge rent by the metre² was flagged as particularly good practice but it was surprising to note that Highfield Allotments is the only one in the district that is charged in this way. Some allotments hold 'open days' inviting visitors, including school children, to meet allotment holders and 'be put to work on an allotment'.

A detailed report on the findings and recommendations following the review is expected at the end of March.

After some discussion, it was **RESOLVED that the update be noted and that the committee considers the final report on the review in due course.**

24028 Environment & Public Realm: The Outdoor Maintenance Officer had provided a written report on works carried out in the last month and planned work in the coming weeks.

It was reported that turf had now been laid at Crag Bank Village Hall to replace the shale; planters in the War Memorial Gardens have been prepared for the spring and improvements made to Noticeboards.

Trees at the War Memorial Gardens, having been cut back by contractors employed by Booths, are reported as being 'manageable' for maintenance by the Outdoor Maintenance Officer. It was noted that before any work is carried out by the Outdoor Maintenance Officer an agreement needs to be approved and any remuneration agreed and a full risk assessment carried out. A similar arrangement needs to be in place before Carnforth Town Council can take on responsibility for cutting the grass in Alexandra Park. Subject to proper approval, the Outdoor Maintenance Officer is confident that the work can be undertaken within existing hours, but the position will be closely monitored in any case. **ACTION: Town Clerk to liaise with appropriate organisations to develop draft agreements for consideration by this Committee and any recommendations made to Carnforth Town Council for approval.**

The community plot on the allotments is nearing completion and scaffolding planks to improve the footpaths are being ordered, funded from the allotments budget. It was reported that a bus shelter on Lancaster Road needs some attention. **ACTION: Ownership of the bus shelter in question to be established and arrangements made for its repair.**

After some comments, it was then **RESOLVED that the reports, updates and actions be noted and progress reported in due course.**

24029 Civic Hall: The Facilities Manager reported on some relatively minor repairs needed to stonework near the main entrance that needs 'waterproofing' through the application of specialist paint.

It was **RESOLVED that the actions and updates be noted and progress reported in due course.**



It was reported that all users had been kept fully informed and that an 'informal' meeting with one user is being arranged urgently.

It was reported that the surveys commissioned by Carnforth Town Council have been completed and that a detailed report is on schedule to be reported by the end of March.

It was then **RESOLVED that the update be noted and that matters raised be 'confidential' and not for general discussion outside the meeting nor made available to the general public should a request be received to view related papers / information.**
